### BACKSTAGE

#### ENTRANCE, LOADING DOCK AND TRUCK & BUS PARKING

- artist entrance, parking and loading docks via entrance Meeuwerderweg
- the area is locked by a gate, easy entrance
- bus power (230V 16A CEE/32A 3ph. CEE) can be provided on request
- in case of arriving overnight, please let us know in advance

### DRESSING ROOMS

6 dressing rooms (5 with showers and toilets). Dressing rooms are situated on the first floor (spiral staircase). All dressing rooms are lockable and are furnished with tables, chairs, mirrors, adequate lighting, power outlets, a small fridge and a clothes rack.

### GREEN ROOM

This room (± 90m<sup>2</sup>) is situated near the dressing rooms of the Main Hall on the first floor. The room is furnished with a sink, hot & cold running water, electricity, tables and chairs (capacity 25-30 people) and a small fridge. A large fridge can be provided on request. Please note: gas cooking is not allowed.

### PRODUCTION OFFICE AND WIFI

One of the dressing rooms can be used as a production office. Free wireless internet available in all areas.

### DINNER

There is an in-house restaurant at De Oosterpoort. If you have any questions regarding catering or hospitality, do not hesitate to contact venue's production manager.

- Transformers: 230 > 110v: 2 x 1 kW

### **SOUND LIMIT**

Due to sound level restrictions and regulations it is not allowed to exceed the following maximum sound level: Max 103 dBA at the FOH sound desk, LAeq 15 minutes. De Oosterpoort reserves the right to reduce the sound level when necessary.

### **BACKLINE**

We will presume artist will carry all backline unless otherwise agreed. In case De Oosterpoort will have to rent backline, we will need specific backline requirements well in advance.

### **GRAND PIANO**

A grand piano (Yamaha C7) can be provided by the venue. Extra costs for tuning will be for account of the artist.

### **BARRIER**

On request only. If artist has a specific reason why barriers should be used, please let us know advance. Please note: use of a barrier reduces the capacity with 50. Costs for the barrier and additional security guards will be for account of the artist.

### **FIRE PROOF CERTIFICATES AND RESTRICTIONS**

There are strict regulations governing the use of pyrotechnical devices, smoke and fire effects on stage. Please contact venue's production manager well in advance if your production involves anything like this. All scenery, back drops et cetera must be flameproof and comply with all Dutch fire and safety regulations. The use of any kind of confetti, snow, glitter, foam or bubble machines is not allowed, unless otherwise agreed well in advance.

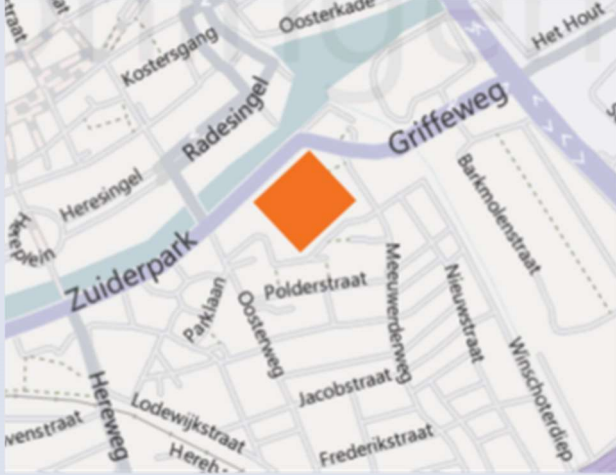
